Relay for Life 2018

There is strength in numbers and that was demonstrated last Friday at Stonewall's third annual Relay for Life walk. Nine teams and 82 participants raised \$18,257.45 for the Canadian Cancer Society that will enable change through the generosity of those who have donated.

For 20 years, the Canadian Cancer Society Relay For Life has united communities across Canada with teams of family, friends and colleagues joining together to celebrate cancer survivors, remember those we've lost and commit to raising funds.

"Far too many of us here today understand how cancer can change everything. Whether it is through our own diagnosis, or that of a loved one or friend, we're all here because cancer has touched our lives," said emcee Natasha Tersigni.

"At Relay, we celebrate survivorship and also recognize the profound loss that cancer has in our lives. Survivors are the heart and soul of Relay For Life. It doesn't matter if you were diagnosed 10 days ago or 10 years ago, we honour your strength and courage," she said.

Following a warm up lead by fitness instructor Sarah Todd, survivors, in yellow t-shirts were lead by the Khar-tum Pipes and Drums band in the opening lap of the Relay. Survivors released yellow helium balloons following the opening lap to represent a release of grief and as a celebration of

life.

Local band Past the Perimeter performed two sets on the outdoor stage providing music for the walkers while members from each team passed the baton after each lap. Fifteen year old musical talent, Teagan Sheppard also shared a few tunes with the crowd following the luminary ceremony.

A luminary ceremony was held to remember and honour those who have been affected by cancer.

"The path of luminaries reminds us that we are all connected. And that we can only see the end of cancer if we work together," said Tersigni.

"We know that the Relay For Life event also couldn't happen without the dedicated team of volunteers who have been working tirelessly behind the scenes."

"Lana Meier has been an incredible leader and with her volunteers, they have made this event happen."

Several participants completed 50 laps including Murray Chatfield, Lisa Wutzke, Kallannah Tonner, Saige Munroe and nine year old Ryden Dalglish.

RBC also donated \$1,000 to the event along with five staff who volunteered their time and managed the finances throughout the evening.

Provincial government invests in public schools infrastructure

Four schools in Lakeside constituency to receive upgrades

Ralph Eichler, MLA for Lakeside, is welcoming news that the Manitoba government is investing in local public school infrastructure renewal projects in the Lakeside constituency.

"Our Progressive Conservative government is proud to invest in our local schools to ensure they are safe, healthy and accessible facilities for Manitoba students," said Eichler.

"These projects will help to improve the learning environment for the children of Lakeside."

The Manitoba government is investing over \$54 million in education infrastructure renewal projects across the province. This province-wide investment includes four in the Lakeside constituency. The local schools that are receiving upgrades are:

- Teulon Elementary (HQR foundation replacement/heating system replacement)
- Stonewall Collegiate (roof structure upgrade)
- Stonewall Centennial (roof structure upgrade)
- Ecole R.W. Bobby Bend (roof replacement)

This investment is part of planned capital spending of over \$129.5 million in 2018-19 for public school infrastructure projects capital across the province. Construction for many of the projects is already underway or complete, with all projects expected to be complete by the end of 2020.

Woodlands fall supper celebrates 70th anniversary

The Woodlands Community Fall Supper is marking a mouthwatering milestone this Thanksgiving when they will be serving up the seasonal meal for the 70th year.

On Monday, Oct. 8, all are welcome to come to Woodlands Hall (204 Argyle St.) for the much-awaited meal, which will be served from 3 to 6 p.m. Take-out meals are also available.

Organizer Wendy Proctor said the event is always held on Thanksgiving Monday, and they usually seat about 600 people.

"The Woodlands Anglican Church group used to do it, but then those ladies got to the age when it was time to pass it on," she said.

"So our Woodlands District Ladies Group was formed, and this will be our 11th year doing the fall supper."

Diners can look forward to indulg-

ing in a meal of turkey, ham and all the trimmings, as well as an impressive array of homemade desserts.

"We're very lucky we have kids in Woodlands Elementary School and from Warren Collegiate that come and volunteer their time for us both the day before and the day of," Proctor said.

"We also have numerous people in our communities that donate things to our fall supper so we don't have to purchase items like cranberry sauce, butter, coffee, tea, pickles, Cool Whip, all those kind of things."

Of course, more volunteers are always welcome to help out. Anyone who is interested can contact Proctor at 204-383-5295.

"On Sunday morning (Oct. 7), we'll be at the hall at 9 a.m. prepping everything, so anyone is more than welcome to come and just ask to speak to

me," she said.

"On Thanksgiving Monday, we need help with a variety of things, so just give me a call."

For many people from near and far, they look forward to the Woodlands fall supper every year.

"You do see those families that come year after year, so it's always nice to see them. It's wonderful. It's a huge community thing, which is important," Proctor said.

"Most of the people that attend the fall supper are outside the community. We have people from our community that attend for sure, but there are lots that I don't recognize, so I would say they're probably from outside the community."

Although the temperature has recently dipped, Proctor is hoping for some agreeable weather for the event.

"Hopefully we have a nice day. Even

if we don't have a nice day, we usually have a decent turnout," she said.

"We have room inside the hall to wait so they don't have to wait outside. A nice day is always better, but Mother Nature makes those decisions so we get what she gives us."

The cost of the Woodlands fall supper is \$15 for adults, \$6 for kids age six to 10, and free for wee ones age five and under. There are no reservations available.

"Any money we raise, we give back to organizations in our community," Proctor said.

"We've given to all the organizations in our community from the rec centre and the museum to the school and the hall. It's a really great event and a great way to give back."

Province invests nearly \$10 million to upgrade health facilities

Much-needed investments will benefit patients across the province

The Manitoba government will upgrade health-care facilities across the province by investing approximately \$9.7 million in 13 new projects, Health, Seniors and Active Living Minister Cameron Friesen announced earlier this week.

"Proper building maintenance and upgrades are needed to make sure the facilities remain in good repair, are safe for patients, staff and visitors, and continue to ensure the provision of quality care," said Friesen. "These much-needed investments will benefit patients across the province."

The minister noted several of the projects include work to improve fire safety and sprinkler systems in personal care homes and health-care facilities, as well as upgrades to emergency medical service (ambulance) facilities.

The projects include:

- the second phase of a sprinkler installation project at E.M. Crowe Hospital and Personal Care Home in Eriksdale;
- a new fire alarm system for Rosewood Lodge in Stonewall;
- a new fire alarm system for Arborg and District Health Centre;
- a new, two-bay emergency medical services facility in Easterville;
- asbestos removal in the kitchen area at The Pas Health Complex, as well as upgrades to humidity control in the operating room;
- a hot water system replacement at Winnipegosis Health Centre;
- a fire stop and fire separation installation at Children's Hospital in Winnipeg;
- the second phase of a sprinkler installation project at Victoria General Hospital in Winnipeg;
- a new operating room air-handling unit and dehumidification con-

trol installation at Winnipeg's St. Boniface General Hospital;

- a new air conditioner at Action-marguerite St. Joseph in Winnipeg; and

- the upgrading of suicide prevention equipment at the PsychHealth Centre and Addictions Unit at Health Sciences Centre Winnipeg.

Each year, the regional health authorities, CancerCare Manitoba,

Shared Health and the Addictions Foundation of Manitoba submit requests for safety and security projects at sites across the province. Timely equipment replacements, upgrades and repairs ensure services continue to be available for patients.

Work will begin once the projects are publicly tendered and awarded, the minister noted.

Conserving land for wetlands more important than ever

Dear Editor,

Ducks Unlimited Canada is pleased with the findings of a recent Insurance Bureau of Canada (IBC) report that identifies a greater need for wetlands and other natural infrastructure as a cost-effective way to limit the expensive damage done by floods and extreme weather.

We hope the report — combined

with recent funding announcements for green infrastructure and initiatives that reduce the potential impacts of natural disaster and the recently passed Sustainable Watersheds Act — will encourage governments, municipalities and conservation groups to pursue new projects together.

In its report, Combatting Canada's Rising Flood Costs: Natural infra-

structure is an under-utilized option, released on Sept. 18, IBC provides a way to assess the total economic value, benefits and potential for natural infrastructure such as wetlands. It concludes that governments and water managers need to consider these natural alternatives, alongside con-

The 'Great Andromeda Nebula' can be seen in the October skies

This is my favourite time of year to stargaze. The autumn season is underway and darkness falls early in the evening. This gives me lots of time to be outside under the stars after dinner and well before bedtime. The temperatures are moderate as compared to late fall and winter nighttime observing.

When you look up at the night sky after sundown all of the stars you see belong to the Milky Way.

The Milky Way is the galaxy, or city of stars, in which we reside. The universe contains countless numbers of these "star cities." As the Earth revolves around the sun we see different portions of our galaxy in the night sky during the year. Our galaxy is shaped like a giant pinwheel in which we are located about halfway from the centre to the outer edge. The summer nighttime sky reveals multitudes of stars because we are looking towards the centre of the Milky Way. Since most of the stars form the central portion of our galaxy we see a misty like band of white light stretching across the night sky at that time of year. This band is the myriads of stars belonging to our galaxy. The centre of our galaxy is in the direction of the constellation Sagittarius and the arms stretch across the sky to Cassiopeia. The wintertime night sky gives us a view opposite the galactic centre along the Orion (we are in this area) and Perseus arms. The spring and fall nighttime views are out of the Milky Way galaxy so much fewer stars are seen.

On any night, from a dark site, 1,500 to 2,000 stars can be seen with the naked eye. From town this number is greatly reduced to around 50. All of the stars we see (without optical aid) belong to the Milky Way galaxy.

There is one object that can be seen with the un-

aided eye that is not part of the Milky Way galaxy. This object is another "star city" called the Andromeda Galaxy. Most of the stars we see are well within 1,000 light-years of Earth. A light-year is the distance light travels in one year. Our galaxy is 100,000 light years in diameter. We are located about 25,000 light-years from the centre. The Andromeda Galaxy is very distant at 2,500,000 light-years, meaning that the light we see today left the galaxy 2,500,000 years ago. We are in effect looking back in time when we see this object.

To find the Andromeda Galaxy it is best to look from a dark sky site. Using a basic star map will assist you in finding the constellations of Pegasus and Andromeda. Locate the "Great Square" asterism of stars in the constellation of Pegasus in the eastern sky. The Great Square will be a diamond shape in the sky from our perspective. Locate the left star (Alpheratz) and follow the line of stars in the constellation of Andromeda. Just above the star Mirach

in the constellation Andromeda will be the galaxy. A set of binoculars will reveal a fuzzy cloudlike object in the area. That will be the galaxy of Andromeda. Once you have found the galaxy try looking without the binoculars and you will notice a fuzzy diffuse object. A small telescope will show the galaxy as a misty area with a bright core. It was long believed that the Andromeda Galaxy was just a nearby nebula (gas and dust cloud) within our own galaxy and was referred to as the "Great Andromeda Nebula." It was only since 1912 when it was realized that this object was not just a gas cloud but a separate city of stars a great distance from our Milky Way galaxy.

About an hour after sunset Saturn is visible low in the south-west during October. Despite its low altitude the Ringed Planet is still spectacular in a small telescope. It sets around 11 p.m. at the beginning of October and 9 p.m. by month end. Mars is fading but still brilliant against the stars of Capricorn. The Red Planet is at its highest due south around 9:30 p.m. at the beginning of October.

The moon can be a good guide to finding the planets. The crescent moon can be found to the upper right of Saturn on Oct. 14 after sunset. A waxing gibbous moon is located to the right of Mars on the night of Oct. 17 and to the left of Mars the next night.

crete and steel solutions, for managing water on the landscape.

This new assessment tool will allow governments, municipalities and conservation groups to make a business case for preserving and restoring wetlands.

Further, in new funding under the Canada Infrastructure Program, DUC sees an opportunity to partner with Manitoba municipalities and watershed districts.

We already have successful programs in place. As a conservation leader with more than 80 years of experience, DUC is in a strong position to provide natural solutions that address flooding and extreme weather. In fact, we've worked with landowners to protect and restore wetlands for decades, and we're constantly seeking new partners to continue that work.

Not only do wetlands slow the flow of water and help prevent flooding, they filter nutrients and provide clean water, supply wildlife habitat and store climate-changing carbon.

Wetlands continue to be lost, but we hope the report, recent funding announcements, and the new act will foster the culture of conservation that continues to grow in Manitoba.

Rosser School students attend municipal meeting

• With an early interest in municipal politics, Rosser School's Grade 3 and 4 students observed part of the Sept. 11 meeting and asked council some questions.

• Rosser Reeve Frances Smee has been appointed as the presiding officer of the Board of Revision, which will also include Kelvin Stewart, Angela Emms and Robert Brown.

• Rosser Central Community Club will receive a \$2,195.69 recreation and cultural grant for the payment of their 2018 property taxes.

• The RM of Rosser is requesting that Project Manage-

ment Services of the Manitoba Water Services Board complete a water distribution and sewer collection system in the Local Improvement Plan No. 2 area.

• Council conditionally approved an application to remove topsoil from a property on Mountain View Road. For the same property, council approved an application for a culvert crossing, and the applicant will be responsible for the cost of supplies and installation.

• Council approved a quote from Jessica Manness of JME Engineering for the completion of the Grosse Isle Secondary Plan at a maximum cost of \$5,000.

• Resident Terry Wedge applied for conditional use to build a single-family dwelling in a property in the agricultural general zone. Council approved the request with conditions.

Surviving a stormy situation

Hi gang.

Come experience with me how a Lowe Farm prairie boy wound up fearing for his life desperately navigating an old canvas-covered, wooden-ribbed canoe in a vicious storm on the Lake of the Woods.

Ernie Reimer was a young, strong, slim guy with short brown hair and an intense nature some 50 years ago as he fished from his canoe off the Clearwater shore. His canoe was well built with high sides dispelling any concern for the wind that was stirring the water up into high, choppy turbulent waves. He had caught one pickerel and as he gazed from the restless water to the heavy clouds darkening the sky his rod dove into a wave out of sight. He tightened the drag on his reel and hauled up.

A huge pickerel on the end of his line tore from the top of a wave peak, twisting wildly, its white belly stark against the dark blue, low clouds. He wasn't anchored, and as he bent over, to unhook his landed fish, the canoe lurched to the left, almost throwing him overboard. Looking up, he could see sheets of rain riding on gale-force winds coming at him. He strung and tossed the fish to the front of the canoe and then grabbed his oars, locking them into the oar locks. He knew he was in trouble. He swung the boat

into the wind as the rain hit seemingly from all directions.

The water began churning. He braced his legs against the sides of the canoe, dug his feet into the edges of the wooden webs and began pushing and pulling with his oars, jockeying his craft like a kayak in the rapids. He ducked his head, squinting trying to see through the now-biting sheets of pounding rain. The water seemed like mountains above him. Walls of water slammed over the side of the craft. He scanned over his shoulders, getting his bearings for a shoreline the wind would take him to. So he worked his oars backward and forward facing the wind, he and his canoe tossing wildly high and low but always falling back shoreward.

In time, Ernie could hear the waves crashing against the banks behind him. A sideways wave hit the boat, slamming Ernie's shoulder into the side of the craft. His arm went numb. He couldn't work the oar. Then another wave hit, turning the canoe over as he felt and heard its side scraping the mud and stones at shore. He crawled, submerged from under the canoe and rising with his back to the wind, and grabbed the canoe with his good arm. He hauled it to solid land on its side. He pushed it over with the bow on high ground, so as he crouched shiv-

ering under it for shelter, he could see at the shore's edge his two fish on his string being tossed at him from a cascading wave!

I have always admired business folks who, through sheer drive, make something out of nothing. I was talking to Larry Chesley of Petersfield a while back who has a resort and campground on Netley Creek and learned something new. It seems, years ago, he held gigantic private fishing derbies. He would have hundreds of ice fishing holes drilled then do something I had never heard of before. He would red tag and release some fish before the derby, and if you caught one, you would get \$50 cash. He also had a yellow tagged fish worth \$1,000 if you caught it.

"Our efforts worked out to about \$0.14 per hour then, but that's how we got our operation going," Larry said with a hearty laugh.

Last Tuesday, I met a couple of real fun-loving characters, Wayne and Jim Klimchuk from Stony Mountain, who were just landing their boat off the Red at Breezy Point. After introductions, Wayne told how one day not long ago he was sitting on the bank not far from here and Jim was sitting in the back of their boat they had beached. Wayne caught something that jumped high out of the water.

"Do carp jump in the air like that?" Wayne asked.

"I don't think so," Jim came back.

"Well, it's got to be a sturgeon then," Wayne said.

Without warning and for no apparent reason, Jim jumped into the water wet up to his waist and grabbed the beast in a bear hug. The sturgeon didn't like that and Wayne screamed in laughter as he watched Jim getting smacked in the face with its head and in a lower place with its tail. Jim walked it to shore and unhooked it, but as he released it, it gave him one last smack in the face with its tail for good measure.

Life's a puzzle







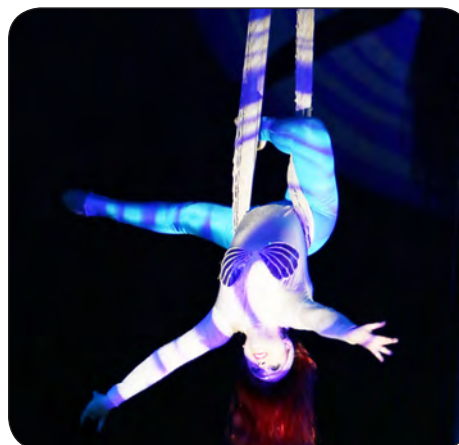

It was a typical summer night, sitting around the campfire at the lake. Friends and family, lots of laughter, toasting marshmallows, partaking in a few beverages.

"Why is it that I can find out on Facebook who is changing the colour of their hair, what they are serving for supper or if the laundry has been done that day? But ... I cannot find out why the RCMP gathered north of town looking for a missing body."

This, folks, is the plain and simple truth about why journalism matters.

Because the facts and the truth are ferreted out by credible journalists whose writings fill the pages of community newspapers and national dailies.

No one reads newspapers anymore, you say. Wrong! Nine in 10 Canadi-

ans read content that was originally generated from a newspaper each week. Canadians turn to newspaper information on a number of issues. It could be the details of a government program or updates on NAFTA talks or what the stock market is doing. In the case of a community newspaper, readers seek out information on town council happenings or school events or delight in seeing a picture of their children on the front page.

Journalists not only gather the news, they also confirm the sources and double check the facts. In a world where information is instantaneous, it is surprising that 63 per cent of Canadians are unable to distinguish between legitimate news websites and fake news stories. Another important reason why newspaper journalism

matters ... now more than ever.

There is a cost to newspaper journalism. These news-gatherers like to be paid, as does everyone who works for a living. The owners of the news outlets, whether a national corporate or the independent owner, have bills to pay. One of the largest forms of revenue is advertising sales.

Unfortunately, the mistaken belief that everyone can be reached through social media has caused advertisers to abandon newspapers. Many studies find that ads in newspapers are the most trusted of all. Newspapers do not share your data, either.

Arthur Sulzberger Jr. said, "Newspapers cannot be defined by the second word — paper. They've got to be defined by the first word — news."

News is important — at the national

level and at the local level. Journalism matters because democracy matters. It is what defines us as people who are fortunate to live in a free country. Newspapers matter because their credible journalists provide the facts and the truth that we deserve.

National Newspaper Week will be celebrated the first week of October with this year's theme "Newspapers Matter: Now More Than Ever." At this time, Canadians are being asked to show their support for the industry. Send a message to governments, to Canadian business, to journalists that newspapers matter. Pledge your support at newspapersmatter.ca.

Manitoba's roster includes Grosse Isle's Olivia McCowan.

"I'm super excited and our whole team is excited to host the other teams and bring ringette to our city," said McCowan last week. "We're really excited to bring this level of ringette to Winnipeg."

McCowan is looking forward to being able to play elite competition

while getting to go home every evening.

"It'll be really fun to go play against other provinces from all over Canada and then come back and sleep in your own bed," she said. "It'll be really nice."

Most of the teams should be very competitive at the tournament.

"All of the provinces are sending kind of their top 20 players for this program," McCowan said.

The Interlake Lightning finished with an 0-4 record at the Female Midget Capitals Showcase last weekend in Portage la Prairie.

The Lightning will host the Balmoral Hall Blazers' prep team in a preseason game Saturday (6 p.m.) in Stonewall.

On Sunday, Interlake will play the Avros in its regular-season opener at 3 p.m. in Warren.

An estimated 28 players came out for the Lightning tryouts, which is one of the largest numbers that they have had, according to Rebeck.

Rebeck's goal is to build a strong Female Midget hockey program in the Interlake. He has a strong coaching staff this season, which includes Tess Dusik and Madi Biluk.

Rebeck expects the Lightning to be a much different - and better - team after Christmas compared to late September.

"Execution is going to be key for us and that's what we're going to work on in practice," he said. "Hopefully, they can learn the systems and work as a team together."

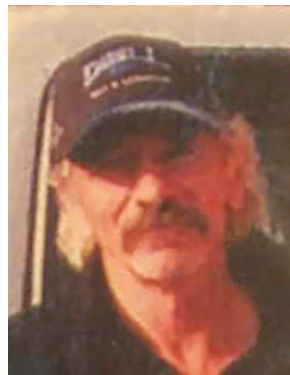
